

## 2013 SURVEY OF REGISTERED AND ACTIVE VOTERS IN RHODE ISLAND SURVEY RESULTS

Methodological Note: the obtained sample consists of 401 registered voters with at least a nominal voting history. The sample was derived from a random selection of individuals from Rhode Island's voter registration rolls, excluding those without a telephone number or with no voter history. Interviews were conducted by telephone from January 31 to February 2, 2013. Interviewing was conducted via both landlines and mobile telephones. The obtained sample was weighted in a two-step process by age and sex, then by party affiliation, in order to make the obtained sample conform to known characteristics of the sampling universe. The margin of sampling error for a sample of 401 is  $\pm 4.9\%$ .

  - 100% YES (CONTINUE)

    - 0% DON'T KNOW/NO RESPONSE (THANK AND TERMINATE)
- 2. Are you, or is anyone in your household, employed with an advertising agency, newspaper, television or radio station, or political campaign?
  - 0% YES (THANK AND TERMINATE)
  - 100% NO (CONTINUE)
    - 0% DON'T KNOW/NO RESPONSE (THANK AND TERMINATE)
- 3. How would you say things going in the state of Rhode Island today: would you say Rhode Island is generally headed in the right direction, or is it headed in the wrong direction?
  - 37% RIGHT DIRECTION
  - 53% WRONG DIRECTION
  - 10% DON'T KNOW/NO RESPONSE



- 4. How would you rate the job performance of Governor Lincoln Chafee: has his job performance been excellent, good, only fair or poor or have you not heard enough to say one way or the other?
  - 4% EXCELLENT
  - 21% GOOD
  - 35% ONLY FAIR
  - 31% POOR
    - 7% HAVE NOT HEARD ENOUGH TO SAY ONE WAY OR THE OTHER
    - 2% DON'T KNOW/NO RESPONSE
- 5. Have you heard or read anything in the news recently about the issue of same-sex marriage in Rhode Island?
  - 96% YES
  - 4% NO
  - 0% DON'T KNOW/NO RESPONSE
- 6. Recently, the Rhode Island House of Representatives voted to redefine marriage to include two persons of the same sex. A resolution has been introduced in the Senate to allow the people to vote on the definition of marriage. Which of these two positions do you think is correct: do you think the definition of marriage should be decided by the voters of Rhode Island, or should it be decided by the Rhode Island General Assembly?

- 15. Generally speaking, do you think of yourself as a Republican, a Democrat, an Independent, or as something other than these? IF REPUBLICAN OR DEMOCRAT, ASK: Would you call yourself a strong or a not very strong (Republican/ Democrat)? IF INDEPENDENT OR ANYTHING ELSE, ASK: Do you think of yourself as closer to the Republican or Democrat Party?
